#### AGENDA:

Chris Johnson, Reba Webber, Kurt Bahti (he left about 0940), Annette Dorney, and Sue Archibald (left about 1100) all present. Brenda Tranchina, Staff and members of the public also present.

#### C. Pledge of Allegiance.

Prior to call to the Public, Chris Johnson gave the following notice:

- 1. <u>Privacy</u>: One of the districts highest priorities as an organization is to respect the privacy of it's members, employees and volunteers. This means that we will not comment on private information on its members, especially when it's related to their job or function in the district.
- 2. <u>Speculation</u>: The district will not act on speculation or rumor, especially in personnel matters, except to research for confirmation if we have reason to believe it's relevant, confirmable, actionable, and related to job performance. The district will only act on data that can be confirmed. Actions taken will be subject to the Privacy restrictions.
- 3. Open meetings Call to the public: An individual public officer may respond to criticism, ask staff to review an item or ask that an item be placed on a future agenda, but he or she may not dialogue with the presenter or collectively discuss, consider, or decide an item that is not listed on the agenda. A.R.S. § 38-431.01(H); Ariz. Att'y Gen. Op. 199-006.

#### Call to the Public. Limited to 3 minutes

- 1. Chaplin Mike Wright spoke a prayer over the board, department and public present.
- 2. Gary Soliere revisited the past history of SEFD and how Chief DeWolf accepted the Chief position when no one else would. How SEFD had membership dues that more than half the community didn't pay, so decision was made to form a district. Chief has brought in a large number of grants and funding to keep the district taxes down. He wanted to thank Chief DeWolf for all of his hard work.
- 3. Nancy Belt Her comments relate to #6. Her daughter filed a complaint 2 years ago and has heard nothing. As elected officials, the Board has a responsibility to respond to complaints.
  - She is an employer and she would investigate any complaint made against her employee. Also, she recognizes doesn't get first hand information about complaints, but she feels that since the Chief is a high profile person, complaints need to be investigated.
  - What is the basis for Chief's review? Do you talk to personnel and ask what they think of the Chief and how he is doing?
  - What are you going to do about these allegations?
- 4. Jordan Cox Discussed how SEFD used to have a lot of volunteers and now SEFD doesn't seem to have them and the staff seems thin.
  - What is the Board doing about the succession plan, replacement of personnel ie BC leaving, captains leaving and poor moral? Why is it so bad?

6) Discussion and possible action on the review and handling of letters received from members of the public expressing concern related to various District issues. Johnson

Chris Johnson stated that he is speaking with the district attorney and the HR person. It has been suggested that the Board go into an executive session to discuss how they can handle the letters appropriately while maintaining privacy. It is complicated because of the chain of command. Sue Archibald thanked the public for coming forward and expressing their thoughts and opinions and participating in the meeting. Reba Webber agreed with Sue, but also stated that maybe the Board needs to communicate better. The Board wants to be transparent. Chris Johnson mentioned the open public meeting laws are very specific and does tie the Boards hands when dealing with personnel issues. He referenced that people can look up the Open Meeting Laws themselves and read them. The Board has been working with the Chief since Jan 2020 on solutions. Kurt Bahti has spoken with people and the Board is operating according to the law, but the Board will address this.

In order to move forward, they will schedule an executive session to discuss this. Agreed date and time is **August 27**<sup>th</sup>, **2020 at 0930**. All board members are available. Annette Dorney will reschedule her appointment on that day. Chris Johnson will work with Laura on the agenda and postings.
