Motion carried unanimously.

Item #12 Regarding referral of unauthorized payments to the county attorney's office for review and potential recovery of payments: Motion by Dorney to refer the former Fire Chief to the county attorney's office and direct SEFD attorney Donna Aversa to initiate the referral and facilitate providing SEFD information to the county attorney's office, seconded by Webber. Motion carried unanimously.

Budget study session – The Budget study session was dedicated to discussion between the Acting Chief and board members directly related to the proposed budget. The Board elected to have a special budget study session on April 19, 2021 at 0900.
