## A. Consideration and possible adoption of draft Rules and Procedures

Chair Archibald called for a motion and discussion as to the draft Rules and Procedures contained in the Board Packet. Member DeWolf made a motion to adopt the Rules and Procedures with correction, as counsel had been instructed to add, during Executive Session, effective today. That motion was seconded by Ms. Sink, and opened up to discussion. A confirmation of the necessary amendments occurred, which included the appropriate date(s) for pre-existing condition determinations to be made. The usual practice is to use the date of System joinder, for matters of PSPRS eligibility, which may be added by the Board on a retroactive basis, to ensure statutory compliance. That date will be added, subject to further review, as two District Members, appear to have a grandfathered date for their service credits, which is earlier than the joinder date.

Following that discussion, the motion passed by a vote of three to one, with Chair Archibald, Captain Jackson, and Member Sink voting the affirmative, and Member DeWolf voting against the motion.
